Health Updates

Screenings

Each person who enters the school will have their temperature checked before they are allowed entry. Only faculty members and students will be allowed into the building. If a temperature exceeds 100°F you will be called to pick up your child immediately.

All parents and faculty members must complete the form on our website each day to affirm that they are healthy and in compliance with present CDC guidelines.

Faculty, staff and students must stay home if they experience symptoms of COVID 19. If a child feels unwell in any way, he/she should stay home. If you are keeping your child home for any reason, please contact the health office.

Potential Cases

Anyone who is denied entry will be directed to monitor their symptoms and seek the advice of their healthcare provider. If a COVID test is recommended and administered the person should remain quarantined at home until test results are given.

If presenting signs and symptoms during the day while at school students will be placed in an isolation room. The nurse will contact you and refer you to your healthcare provider to see if a COVID test is warranted.

If a person receives a positive result isolation must occur for 14 days after the onset of symptoms. The return to school can only happen after this time and there has been no use of medicine for at least 24 hours. Contact tracing must occur and anyone who has been in close contact with the person must be told to quarantine or get tested.

If a person receives a negative result it is recommended that another test be taken to rule out a false negative. A child may return to school after receiving a negative result if their symptoms have subsided.

If your child has chronic illness, i.e. allergies, which may warrant suspicion it is advisable to have your healthcare provider provide a note that these symptoms are related to a chronic illness and not the virus.
